

## CONDITIONS OF ENTRY

Every person wishing to enter or remain upon these premises must comply with all Conditions of Entry as summarised below:

### Our Right to Refuse Entry or Refuse Service

Management and staff reserve the right to refuse entry to these premises and/or refuse service to any person who, in their judgement:

- shows signs of intoxication or being under influence of an illicit substance
- fails to provide acceptable identification when requested
- fails to meet our minimum Dress Standards
- does not comply with our House Rules or behaves inappropriately
- is aggressive, argumentative or known to be violent or disorderly
- is banned from entering these or other licensed premises
- has been required to leave these premises within the past 24 hours
- is prohibited from entering or being upon these premises by law
- may be refused entry or service for any other lawful reason

Last drinks will be called by management dependent upon patronage and all Patrons must leave our premises within 30 minutes after calling of last drinks.

### Dress Standards

Management and staff reserve the right to refuse entry to these premises and/or refuse service to any person who fails to satisfy any of the following minimum Dress Standards:

- clean, neat, tidy casual attire to be worn at all times
- suitable footwear to be worn at all times (no unclean or untidy footwear)
- no lewd, offensive, inappropriate, damaged or soiled attire
- no manual work clothing or work boots (including hi-vis or steel cap boots)
- jackets or other clothing or accessory or visible body marking/s bearing patches or insignia of any Outlaw Motor Cycle Gang are not permitted to be worn or to be visible on these premises at any time including but not limited to:
  - Bandidos
  - Finks
  - Mongols
  - Brothers 4 Life
  - Gods Garbage
  - Outlaws
  - Club Deroes
  - Gypsy Jokers
  - Rebels
  - Coffin Cheaters
  - Hells Angels
  - Rock Machine
  - Commancheros
  - Lone Wolf

### Acceptable ID

The following are acceptable forms of identification at these premises:

- current Australian Drivers Licence with photograph
- current Australian Learner Driver Permit with photograph
- current WA Proof of Age Card
- current Passport

### Juveniles

- If you are under 18 years of age (a Juvenile) you will be refused entry and/or service unless:
- you are accompanied by and under the supervision of a responsible adult
- you are here for the purpose of a bona fide meal (while seated at a table)
- all Juveniles must leave these premises by no later than 10 pm

It is a serious offence to purchase or attempt to purchase alcohol for a Juvenile and any such purchase or attempt to purchase alcohol for a juvenile will result in your immediate removal and banning from these premises.

**During COVID-19 pandemic (Additional Conditions of Entry)**

In addition to Conditions of Entry displayed at the main entry to these premises, during the COVID-19 pandemic any person/s wishing to enter or remain upon these licensed premises must also:

- not enter or remain on these premises if sick or unwell
- observe social distancing of 1.5 metres where practical
- observe good hygiene practices at all times
- satisfy any other COVID restrictions advised by WA Health from time to time
- for health and safety reasons, agree that Hotel management may take a forehead temperature reading of any person/s wishing to enter or upon these premises who Hotel management believes may show one or more possible symptoms of COVID-19, being unwell or high temperature.
