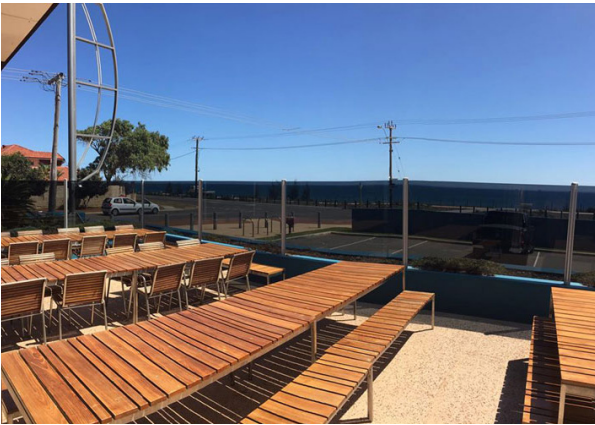

BELONGINGS, EQUIPMENT + GIFTS

The person named on the Function Booking Request Form as the Customer or the Contact Person for the Customer is solely responsible for ensuring that all belongings, equipment, gifts and other property of any kind lawfully belonging to the Customer is collected and removed from the Premises at the completion of the function.

BOOKING CONDITIONS

No bookings will be taken for 18th birthday parties and any person found to misrepresent ages will be excluded from the venue & forfeit all monies paid.

CANCELLATIONS

A full refund will be given to cancellations 21 days prior to the function. Less than 21 days notice of cancellations will forfeit the deposit. Cancellations made less than 7 days prior to the booking will incur a charge of 50% of total cost of the function.

DAMAGE TO PREMISES OR HARM OR LOSS

The Customer is personally and financially liable for any damage or loss to the Premises and/or the business of Broadwater Resort Hotel caused by and/or arising from the function or the Customer. Management reserves the right to require the payment of a Bond prior to confirming any function and, if paid, any Bond paid may be forfeited in full or part in the event of wilful or avoidable damage or loss caused by or arising from the Customer or the function. Any Bond paid will be refunded (if refundable) on the Business Day next following the day of completion of the function.

DEPOSIT/TENTATIVE BOOKINGS

Will be held for up to 7 days. For a function date to be confirmed past this time, a deposit of the full room hire will need to be made.

DECORATIONS

A limited quantity and scale of tidy, modest and appropriate decorations may be supplied and installed by the Customer in the specific area to be directly utilised by and for the function (only), subject to the Customer receiving prior written approval from Management to specify: the agreed time period during which all decorations must be installed by the Customer or its' representative/s; item/s to be fixed to walls or other surfaces must

be attached with blue tac (only) and not sticky tape or permanent adhesives; all decorations must be removed by the Customer without causing any marking or damage to walls or other surfaces or areas; and if all decorations supplied or installed by the Customer are not removed from the Premises by the Customer immediately upon completion of the function and the function area left free of marks or damage then additional charges may apply.

EIGHTEENTH BIRTHDAYS PROHIBITED

Broadwater Resort Hotel will not accept bookings for 18th birthday parties. Any person found or reasonably suspected by Management to have misrepresented a function as not being an 18th birthday party in order to secure a booking or to misrepresent or omit the age of any person attending a function on the Premises who is a minor (under 18 years old) may be denied access to or removed from the Premises and may forfeit all or part of any Deposit/s and other monies paid or payable to the Broadwater Resort Hotel.

ENTERTAINMENT

A DJ can be organised for your function at a fee. Due to licensing commission noise levels, management reserves the right to adjust volumes of music during functions if noise levels are excessive.

FINAL ARRANGEMENTS

Details of all final arrangements must be advised at least 7 working days prior to function.

FINAL PAYMENT

All accounts must be paid in full 7 days prior to the function day by cash or credit card only.

FOOD & BEVERAGE POLICY

No food or beverage of any kind is permitted to be brought into the hotel for consumption, birthday cakes excepted. Any food not consumed remains the property of Broadwater. Broadwater is committed to & abides by responsible service of alcohol.

FUNCTION

The Customer agrees to conduct any function in an orderly manner, respecting the rights of other customers and guests of The Broadwater Resort Hotel. All conduct must be in full compliance with all applicable laws.

for any gifts or goods at the function, or left behind at the conclusion of a function. The customer accepts any damages caused by their guests, and any excess costs for cleaning or repairs will be assessed by the venue manager and passed on to the customer. No nails, staples, screws, blu tac or other fixing materials are to be used without prior consent. We also request that all decorations are discussed with the function coordinator before the commencement of your function.

MINORS

Persons under the age of 18 are welcome in your private function room however, they must be accompanied by a parent or legal guardian at all times & be made known to management & staff on duty. At no time are minors permitted to consume alcohol or be served at the bar. All minors are to vacate the premise by 12am.

PATRON CARE

Under the Liquor Act the following rules must be adhered to when holding a function:

Responsible Service of Alcohol: As licensed premises we are not permitted by law to serve any patron that we believe to be intoxicated. Management reserves the right to refuse service to a customer in these circumstances.

Minors: Minors are not permitted in the venue past 10:00pm and must be accompanied by their parental guardian at all times. Their parental guardian must have a reasonable age gap between them (old enough to be their parent is the general rule). This does not provide access for the minor (even when accompanied by an adult) to other areas within the Hotel i.e. Main Bar, TAB, etc.

Identification: The only acceptable forms of proof of age we accept are a current driver's license, a current passport, an 18+ card. Please note the only International driver's license we accept as proof of age is New Zealand. We reserve the right to refuse service and or entry to any patron unable to provide identification upon request. Please ensure you inform all your guests about the above as no negotiation will be entered into. If any of the above conditions are breached management reserves the right to refuse entry or request that a patron leave the premises immediately and in extreme circumstances may result in the cancellation of your function.

PAYMENT

Payment can be made by Credit Card (phone/

personally), Cash (personally) Please note we do not accept cheques. Should you require a Tax Invoice please request this from the Manager completing your booking. Pricing listed throughout this document and in the attached platter menu is subject to change without notice. Once your deposit is paid however, the price will remain the same. Beverage prices are subject to change without notice and are based on CPI increases.

PROPERTY DAMAGE

Whilst we take all due care with these items, we do not take the responsibility for any items that may be lost, stolen or damaged. The customer holds sole responsibility for any damage that the hotel may incur during a function, including their set up time. This includes, but not limited to, any equipment that may be damaged. Should any person or object sustain any injury or damage, The Broadwater Resort Hotel reserves the right to seek financial compensation.

RESPONSIBILITY

The hotel does not accept any responsibility for damage, theft or loss of personal belongings, or items of any kind in the function room during or after the function

SECURITY

Management has the right to request & organise additional security for evening functions. Photo identification may be required to be presented to staff & security on request. Smart casual dress regulations apply to all guests & management reserves the right to refuse entry to inappropriately dressed guests.

SMOKING

In compliance with the Health Act 2006, guests are only allowed to smoke on the balcony provided. The rest of the tavern is non-smoking.

UNFORESEEN CIRCUMSTANCES

The Broadwater Resort Hotel reserves the right to cancel any booking without notice due to unforeseen circumstances. This may be due to (but not limited to) power outages, mechanical failure or other factors beyond our control
